**ORDINANCE 24-03**  
**AN ORDINANCE FOR THE LEVY AND**  
**ASSESSMENT OF TAXES TAX YEAR 2024 FOR THE**  
**BOURBONNAIS TOWNSHIP PARK DISTRICT IN**  
**KANKAKEE COUNTY, ILLINOIS**

**WHEREAS**, the President and Board of Commissioners of the Bourbonnais Township Park District, Kankakee County, Illinois, did on December 16, 2024, pass and adopt the annual Budget Ordinance for the Bourbonnais Township Park District (hereinafter “Park District”) for the fiscal year of the Park District beginning on the 1st day of January, 2025, and ending on the 31st day of December, 2025, being Ordinance Number 2024-02.

**NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED** by the President and Board of Commissioners of the Bourbonnais Township Park District, Kankakee County, Illinois, as follows:

**Section 1.**     Recital Incorporated. The above recital is incorporated into this Ordinance and shall have the same force and effect as though fully set forth herein.

**Section 2.**     Tax Levy. Taxes are hereby levied upon all taxable property within the Bourbonnais Township Park District boundaries for the fiscal year ending December 31, 2025, for the following specific purposes:

Section 4. Unexpired Appropriations. All unexpired appropriations for the fiscal year ending December 31, 2024, are continued for the purpose for which they were appropriated and levied.

Section 5. Assessment of Tax Levy. The total amount of Three Million Two Hundred Thirty-One Thousand Eight Hundred Ninety-Three Dollars and 00/100 (\$3,231,893.00) ascertained above, is hereby levied and assessed on all property subject to taxation within the Park District according to the value of said property as assessed and equalized for the current year.

Section 6. Certification to County Clerk. There is hereby certified to the County Clerk of Kankakee County, Illinois, the several sums above, constituting said total amount, in the total amount of, Three Million Two Hundred Thirty-One Thousand Eight Hundred Ninety-Three Dollars and 00/100 (\$3,231,893.00) which total amount the Park District requires to be raised by taxation for the 2025 fiscal year of the Park District, and the Park District Secretary of the Park District is hereby ordered and directed to file with the County Clerk of the County of Kankakee on or before the last Tuesday of December, 2024 a certified copy of this Ordinance.


Section 7. Severability and Repeal of Inconsistent Ordinances. Any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Park District are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

Section 8. Effective Date. The Secretary of the Bourbonnais Township Park District shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form, and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.


