ORDINANCE 24-04

AN ORDINANCE AMENDING THE BUDGET FOR ALL CORPORATE PURPOSES OF THE BOURBONNAIS TOWNSHIP PARK DISTRICT, KANKAKEE COUNTY, ILLINOIS FOR THE FISCAL YEAR COMMENCING ON THE FIRST DAY OF JANUARY 2024, AND ENDING THE THIRTY FIRST DAY OF DECEMBER, 2024

WHEREAS, Section 4.4 of the Illinois Park District Code, 70 ILCS 1205/4.4, requires Park Districts to adopt, within the first quarter of each fiscal year, a combined annual budget and appropriations ordinance; and

WHEREAS, the Board of Commissioners of the Bourbonnais Township Park District on December 19, 2023 adopted ordinance 23-07 Fiscal Budget 2024, the Combined Annual budget and Appropriation Ordinance for fiscal year 2024; and

WHEREAS, the Board of Commissioners of the Bourbonnais Township Park District, have determined it necessary to amend ordinance 23-07; and

WHEREAS, Section 4.4 of the Park District Code authorizes park district to amend the budget and appropriations ordinance from time to time by following the same procedures as required for the original adoption of the budget and appropriations ordinance.




