Motion to select the Executive Director as President ProTem. Motion made by Mullinax, seconded by Sadler. All in favor. Motion passed.

O'Shea asked if there was a motion to nominate a Commissioner for board President. Mullinax nominated Zinanni and Bukowski seconded. O'Shea asked if there were any other nominations.

There were none. Mullinax made the motion to close the nomination and approve Zinanni as President. Sadler seconded. Roll Call. Chaplinski-Aye, Sadler-Aye, Bukowski-Aye, Mullinax-Aye, Zinanni-Aye. Motion Passed.

O'Shea asked if there was a motion to nominate a Commissioner for board Vice President. Bukowski nominated Chaplinski and Sadler seconded. O'Shea asked if there were any other nominations. Zinanni nominated Mullinax, Sadler seconded. At this time Zinanni explained how it was in the past, that everyone would hold a position for 2 years, and that way each board member could have an opportunity to hold a position. Since Mullinax has been here the longest, he would be a great consideration. Bukowski stated he has medical concerns in his personal life which draws him out of the situation. Chaplinski added if he knew Mullinax had interest, he would withdraw his interest. At this time, Chaplinski withdrew his name from the nominations. Zinanni made the motion to close the nominations and approve Mullinax as Vice President, Chaplinski seconded. Roll Call. Chaplinski-Aye, Sadler-Aye, Bukowski-Aye, Mullinax-Aye, Zinanni-Aye. Motion Passed.

At this point, Zinanni proceeded with the meeting.

Zinanni asked for a motion to appoint Jamie Boyd as board Attorney. Bukowski made the motion and Mullinax seconded. All in favor. Motion passed.

Zinanni asked for a motion to appoint Amanda Langlois as board Secretary. Chaplinski made the motion and Mullinax seconded. All in favor. Motion passed.

Zinanni asked for a motion to appoint Rob Romo as board Treasurer. Bukowski made the motion and Chaplinski seconded. All in favor. Motion passed.

Zinanni asked for a motion to assign Bukowski to the Living History Committee. Chaplinski made the motion and Mullinax seconded. All in favor. Motion passed.

Langlois read the Oath of Office for Scott Chaplinski and congratulated him on his newly elected term for the board. Chaplinski's board seat will be for 6-year term, which will be the last 6-year term for the board, from here on out, all board terms will be a 4-year term.
